1st German-Sino Agricultural Week from November 16- 19, 2015

The first German-Sino Agricultural Week took place from November 16-19, 2015. This from now on annually scheduled DCZ platform for policy-makers, agricultural practitioners, representatives from industry and science held various events jointly organized with Chinese partner institutions MOA, FECC and CAAS and other BMEL-funded Sino-German bilateral cooperation projects. The whole week attracted hundreds of participants for intensive exchange and networking. It started in Beijing with the “Annual Technical Conference on Chinese milk and beef markets” hosted by the Sino-German Animal Breeding Project, continued with the “DCZ Open Day”, where Sino-German initiatives presented themselves, marked the midweek highlight with the “Symposium on Soil Science and Soil Protection” with top-class speakers and ended with the Official Opening Ceremony of the Sino-German Crop Production and Agrotechnology Demonstration Park at Huanghai State Farm in Jiangsu Province.

All events were accompanied by Parliamentary State Secretary Mr. Peter Bleser and his delegation of the German Ministry of Food and Agriculture (BMEL), and Vice-Ministers from the Chinese Ministry of Agriculture (MOA).

2015, November 16 -17

The **4th Sino-German Annual Technical Conference** on Chinese milk and beef markets hosted by the Sino-German Animal Breeding Project took place on November, 16 and 17, 2015 in Beijing. ADT Projekt, the implementing agency in cooperation with National Animal Husbandry Service (NAHS) invited more than 80 participants.

The symposium presented the current results and findings of the Chinese and German project work. As success factors of sustainable cattle production systems, contributions from the German cattle breeding sector, the business optimization and the German precision dairy farming were discussed (such as Vereinigte Informationssysteme Tier (vit), Verden, LMS Agrarberatung, Rostock, Landesbetrieb Landwirtschaft Hessen (LLH))

The Sino-German Animal Breeding Project is the first project under the "Sino-German Center for Technology and Innovation in animal husbandry", which was founded based on an agreement between the Federal Ministry of Food and Agriculture (BMEL) and the Chinese Ministry of Agriculture (MOA) from 2010. Main German business partners in the cattle component are Bayern-Genetik, BVN, GGI, and Masterrind.

In 2015, the cooperation in the form of on-site consultation with ten demonstration farms continued or started. These are YiliXinHe (Xinjiang), Urumqi (Xinjiang), Hutubi (Xinjiang), HongFeng (Heilongjiang), Runtong (Hebei), SanYuan (Beijing), Yangping (Sichuan), BDCC (Beijing), Sino Farm (Beijing) and Zhangbei (Hebei). All Chinese partner farms were also present at Sino-German Cattle Symposium.

Advisory missions of German and Chinese experts have been carried out on each of the premises onsite and discussed during the symposium to topics such as fodder, cattle feeding, calculation of rations, herd fertility management, livestock housing, udder health and milk quality and profitability of dairy farming.

Through the assignments of long-term expert Dr. Sven Grupe the onsite advice was significantly expanded again throughout the past year. A joint training for udder health and milk quality was held for employees of all demonstration farms in early summer 2015 in the province of Xinjiang and Hebei. In Germany, a 2-weeks intensive training course for 10 participants from China in the project component pig was conducted in October 2015, which covered all the important parts of the pig production and 6 new business partners (Big Dutchman, Mennochemie, Böhrinher Ingelheim, Caisley International GmbH, Arato, Minitube) were included.

2015, November 17

The “**DCZ Open Day**” took place on the premises of FECC and hosted more than 70 Chinese and German visitors. Throughout the morning and afternoon all six BMEL-funded Sino-German bilateral cooperation projects under the framework of DCZ presented themselves at exhibition stands. Special exhibitors were the German Federal Institute for Risk Assessment, BfR and the Ecological Agricultural Demonstration Project, Liaoyuan City, Jilin Province.

Apart from lively bilateral talks and exchanges on Sino-German initiative at the stands, the Open Day was further marked by various presentations of German and Chinese speakers, who gave an overview of their current work and future challenges. Amongst them were the Department of Policy and Law, Chinese Ministry of Agriculture, MOA, the Department of Science & Technology and Education, MOA the Ecological Agricultural Demonstration Project Proposal, Liaoyuan City, Jilin Province, the Rural Environment and Energy Agency, REEA, the Chinese Academy of Agricultural Science, CAAS and all Sino-German bilateral cooperation projects.

The Open Day was attended by the Parliamentary State Secretary (BMEL), Dr. Peter Bleser and by Yang Yi, Director General of FECC.

2015, November 17 -18

On November 17-18, 2015, a “**German-Sino Symposium on Soil Science and Soil Protection**” was jointly organized by the DCZ and the Institute of Agricultural Resources and Regional Planning (IARRP) of the Chinese Academy of Agricultural Sciences (CAAS). This major event was one of the activities of the DCZ during the “German-Sino Agricultural Week”, and in a broader context, also a part of the UN-FAO “2015 International Year of Soils”.

Over a hundred (50 German and 80 Chinese) participants (soil scientists, soil policy officers, German and Chinese agro-industry representatives, extension services, practitioners and students) attended the event on November 18. Topics dealt with in several sessions included Soil Protection Policy and Strategies, Cutting-edge Knowledge on Soil Science and Soil

Protection, Transfer and Extension: Demonstration Farms in China, and Technological Solutions to Soil Protection. The Concluding Discussion Session was attended by the German Parliamentary State Secretary (BMEL) Dr. Peter Bleser and by Dr. Zhang Taolin, Vice Minister, Ministry of Agriculture (MOA), who took questions from the audience and both delivered their Topical Contributions to the Symposium.

The Symposium began with a small pre-discussion round on Soil Protection attended by high-level German and Chinese scientists and interested persons on November 17. A follow-up tour of soil scientists to the Huanghai State Farm in Jiangsu Province with visit fields took place November 19-20, in connection with the opening of the "Sino-German Crop Production and Agrotechnology Demonstration Park (DCALDP)".

Also on November 18, 2015 the **"German-Sino Agricultural Science & Technology Cooperation Platform"** (S&T Platform) was inaugurated at the Chinese Academy of Agricultural Sciences (CAAS). The S&T Platform, established within the framework of the German-Sino Agricultural Center (DCZ), is now located at the CAAS and jointly operated by CAAS and the Gesellschaft für Internationale Zusammenarbeit (GIZ).

A Joint Declaration of Intent on the S&T Platform was signed by the Parliamentary State Secretary of the German Ministry of Food and Agriculture (BMEL) Dr. Peter Bleser and by Dr. Qu Dongyu, Vice Minister of the Ministry of Agriculture (MOA).

The Implementation Agreement of the S&T Platform was signed by Ms. Ursula Becker, Head of GIZ Cluster Environment, Climate and Nature Conservation of the GIZ Country Office China, and Prof. Dr. Wu Kongming, Vice President of CAAS, in an Opening Ceremony attended by the Parliamentary State Secretary (BMEL), Dr. Peter Bleser and by Dr. Zhang Taolin, Vice Minister (MOA).

The S&T Platform's initial focus will be the research cooperation between CAAS Institutes and the Research Institutes of BMEL. It is, however, explicitly open for collaborations with other German and Chinese funding agencies and research institutions, as well as German universities and Chinese national- and provincial-level universities.

2015, November 19

The **"Sino-German Crop Production and Agrotechnology Demonstration Park (DCALDP)"**, a modern agricultural cooperation project jointly implemented by Germany in China, started with an official opening ceremony in Jiangsu's SKIAD on November 19.

The Opening Ceremony was attended by the Parliamentary State Secretary (BMEL), Dr. Peter Bleser and by Xu Ming, Vice-Governor of Jiangsu Province. It was followed by the first project Steering Committee Meeting of all project and business partners.

In October 2014, China and Germany decided to deepen their mutually beneficial cooperation in agriculture and carry out demonstration projects such as the DCALDP. After six field investigations eventually the Huanghai Branch of Jiangsu Provincial Agricultural Reclamation and Development Corporation that is located in Jiangsu's Xiangshui was chosen to undertake the project.

Covering 2,250 mu (150 ha) of farmland, the Park will serve as a platform, organize demonstration and experiments for crop production, implement practices and trainings for crop production and agrotechnology, and hold seminars and lectures on crop production, operation and management. So far 11 German Business Partners provided machinery, seed and other inputs for demonstration purposes (Amazone, BASF, Bayer Crop Science, Claas, Deutz-Fahr, Grimme, Horsch, Lemken, Pöttinger, Rauch, and Syngenta).
